

CNSW FAIR PLAY DECLARATION Keeping cricket in New South Wales fair, safe, inclusive and welcoming

Cricket NSW is committed to upholding the Child Safe Policies and recognises the important role that children and young people play within our sport and the special care and attention that they need in order to feel safe.

As part of our commitment to children and young people, Cricket NSW seeks to:

- 1) provide a safe and supportive physical and online environment for all Children and Young People, including by:
 - establishing culturally safe environments in which the diverse and unique identities and experiences of Aboriginal children and young people are respected and valued; and
 - paying particular attention to the needs of vulnerable children, children with disability, children from culturally and linguistically diverse backgrounds, and lesbian, gay, bisexual, transgender and intersex children and young people.
- 2) ensure that the experiences of Children and Young People are free from any form of Prohibited Conduct including Child Abuse or Grooming;
- empower Children and Young People to act and respond to behaviour that is not acceptable or inappropriate;
 publicise and make available the Codes of Behaviour that underpin our sport;
- 4) make information available on who Children and Young People can approach if they feel unsafe or they become aware of or are concerned about any form of Prohibited
- 5) establish a reporting framework that allows Children and Young People and others to report any incident affecting the safety and well-being of Children and Young People; and
- 6) provide support services to any Child or Young Person and their families who might be affected by any form of Prohibited Conduct including Child Abuse or Grooming;

Cricket NSW is also committed to ensuring that the sport of cricket remains a safe, welcoming and inclusive environment and that everyone involved with cricket is treated with respect and dignity and is protected from abuse, bullying, any form of harassment, sexual misconduct, unlawful discrimination, victimisation and vilification.

Anyone who has registered as a Cricket Participant in New South Wales, or who is selected to play as part of a CNSW team or squad or who plays in a CNSW competition under the



jurisdiction of the CNSW Code of Conduct Commissioner (as defined in clause 6.1 of the CNSW By-Laws) must always comply with the Integrity Policies as set out below including:

- (a) in relation to any dealings they have with Cricket Organisations or their staff, contractors, and representatives
- (b) when dealing with other Cricket Participants or Cricket Organisations in their capacity as a Cricket Participant/Cricket Organisation; and
- (c) in relation to their Membership or standing as a Cricket Participant or Cricket Organisation in general.

By signing this declaration, as an adult player with Cricket NSW, you acknowledge and agree to comply with, uphold and to take active steps to implement the Cricket NSW Integrity Framework (Integrity Framework) within its organisation and to promote an environment that is fair, safe, inclusive and welcoming. The Integrity Framework is comprised of the Integrity Policies which include:

- CNSW Complaints and Dispute Resolution Policy;
- CNSW Code of Conduct as set out in clause 5 of the NSWCA By-Laws;
- CNSW Member Protection Policy;
- CNSW Anti-Corruption Policy;
- Cricket Australia Anti-Doping Code;
- Cricket Australia Illicit Substances Rule; and
- Child Safe Policies.
